Having inspected the area involved in this event, and understanding same, I fully assume any and all risks of personal injury associated with participation including the conduct of all members of Western Pennsylvania Ski Council, all member clubs, Allegheny Ski & Sports Club Inc., Moonlight Ski League and its volunteers and participants, individual club members, event sponsors, the ski area, and its agents, servants and employees, all of whom are hereinafter referred to as the identified parties.

I acknowledge that I am waiving any and all claims that I, and my heirs and assigns may have.
